
The Importance of Weekly Testing

Limit Asymptomatic Transmission

The infected individual is contagious three days after the moment of infection, but it may take up to 12 days to show any symptoms. 25% of infected individuals never show any symptoms.

It only takes only one contagious person for you to lose containment at your workplace. This can happen anytime and anywhere.



- Kyla educates the employee on COVID-19 Safety in the workplace
- Employee uploads vaccination records
- Employee chats with Kyla daily to report symptoms
- If symptoms or vitals are abnormal, employee is connected to a doctor
- If possible COVID, doctor refers employee for testing
- If COVID positive, Kyla does contact tracing
- Doctor and Kyla manage employee's health until employee is cleared to return to work
- Kyla chats with employee weekly to collect information about employees possible exposure to COVID outside of the workplace



Mobile Testing Clinic Fleet

Come to you, Come to Us, Mix it Up

- Mobile Testing Fleet is available in the greater Bay Area, Sacramento, Los Angeles, San Diego.
 Pre-enrolling other areas.
- We will come to your place of work to test eligible employees weekly.
- Nurse sets up a drive-thru right in your parking lot.
- Nurse scans employees phone and takes a swab sample. Employee is notified of results in the app.
- Total face-to-face time with nurse is around 1 minute.

- Website badges and storefront stickers available.





 - o RT-PCR Saliva Diagnostic test
- Express Mail-in tests (overnight)

Emergency on-site testing is available on request within 24- 48 hours after a positive test result.

- \$0 if testing at least 2x a month
- \$1000.00 per trip if testing less than 2x a month
